Rules

1. All fish must be presented to weigh master at Town Creek Marina between the times designated above.
2. All fish brought to the dock must meet State and Federal size minimums or it will cause all fish to be disqualified.
3. All Fish must be caught on a Hook and Line.
4. All fish must be brought to weigh station by boat.
5. Tie breakers are determined by the weight of the largest fish. *See scoring below.
6. No swapping fish
7. Anyone fishing is required to have a fishing license.
8. The captain of the boat must sign the rules sheet stating he has read and understands the rules.
9. The team is represented by the Captain not the boat.
10. If a 5th fishermen is added to a boat after the start of the tournament you must pay the additional \$75.
11. Lines in water at 6:30am—no earlier.

Scoring

Tournament will consist of up to a 3 fish aggregate weight.

There will be no fishing boundary.

All fish must be weighed in by the designated time
at Town Creek Marina.

In case of a 3 fish tie the team with the one heaviest fish wins.

In case of a total weight tie up to 3 fish, the team with the most fish wins in weight.
